Election Procedures

- Arlington Board of Directors candidates must be residents in good standing (Association dues must be current and paid in full. The candidate cannot have an unsatisfied judgment against them).

- Candidates interested in running for Arlington Park Board of Directors positions must notify the clubhouse of their intent to run for office in writing.

The letter of notification must be postmarked no later than Dec. 31st.

- Ballots will consist of only candidates' names that meet the requirements of notifying the clubhouse in writing no later than Dec. 31st and are members in good standing of Arlington Park.

- Candidates wishing to have a short article in the "Arlington News and Views" introducing themselves to Arlington residents may submit a biography to the clubhouse before the 1st of January.

All candidates eligible for election and any submitted biography shall be published in "News and Views".

- Proxy Ballots will be available 30 days prior to the election at the clubhouse. Members may obtain a proxy ballot within that time at the clubhouse.

All completed proxy ballots must be received at the Arlington Park clubhouse by 1st class US Mail or by sealed envelope hand delivered to the Arlington Park clubhouse on or before the 3rd Tuesday in February in order to be counted.

- Voting for positions on the Arlington Board of Directors starts at 7:00 a.m. and ends at 7:00 p.m. on the 3rd Tuesday in February.

Voting takes place at the Arlington Park Clubhouse. No votes will be accepted at the annual meeting.

- The qualifying ballots will be counted by the election committee on the 3rd Tuesday in February.

The committee will validate signatures and lot numbers as votes are tallied.

- The results will be announced by the election committee at the Arlington Park Annual Meeting, by signage at the entrances of the addition, and printed in the "News and Views".

- Carves out 575 acres as a planned "Family Community" to 1068 families

- The original Developer was Ted Brehm of AFW Properties and now resides in Arlington Park. Additional Developers: American Fletcher, Joe Zehr of Chelsea, Intra Group-Ed McCutcheon, Colonial Homes and Arlington Park Investment Corp.

- The Clubhouse was built in 1974; renovated in 1986 by Architect MSKTD and sits on 3.65 Acres. Estimated value \$800,000. Approximately 11,800 sq. ft. Year round facility. Three rental rooms that will accommodate parties of 220. Parking spaces provide for 250 vehicles at the center. Two racquetball courts and one walleyball court. Three swimming pools open from Memorial to Labor Day. Progressive teaching pool was installed in 1995, our competition pool opened in 1985 and our family pool was installed in 1975.

- Pro Shop was built in 1982. Renovations were completed in 1994 with a Porch enclosure. The Course was designed by Du Wayne Daymeyer and Richard Chilcote. The course opened for play May of 1979. Average rounds of golf 12,519.

A par 3 Executive 9-Hold Course sets on approximately 35 acres. Irrigated greens and tees for open play and outings.

- The Golf Shop is fully stocked and is open seasonally from March 15th through November 15th.

- Consist of 15 miles of walkways behind 1,083 homes for exercise and biking paths. Lit for evening pleasure with over 250 greenway and street lights which offers the benefit of security.

- Arlington currently has the lowest crime rate in St. Joseph Township. A total of seven tennis courts. Courts 3 and 4 are lit for evening play. To extend our tennis season wind screens are located on courts 3-4-6-7. You will find a practice board on court #5. Tennis Pro's are available throughout the summer for lessons teaching all skill levels. Arlington is renowned for our junior programs.

- There are 7 play areas throughout Arlington. Each dedicated and named by the children of the surrounding homes. Rocket Park was erected in 1977. The hill was originally a swamp area filled in by development and fondly used for sledding throughout the winter season. Currently there are 858 children in Arlington

- A network of underground tunnels were designed to accommodate safe pathways for our children to Arlington Elementary and Jefferson Jr. Schools. There are a total of 4 underpasses that bypass our 7 miles of street (a distance that equals from Arlington to the City County Building and back).

- Additionally there are 15 acres of ponds and lakes

- Arlington was designed to accommodate first time home buyers. In one of our 66 duplexes, graduate to one of our 917 luxurious homes and retire to one of our 46 patio/garden homes or for the Leisure lifestyle one of our 39 villa units. - Arlington Park has been featured in four Parade of Homes 1973-1980-1985 & 1986.

Snowmobiling...Not Permitted

Indiana Snowmobile Laws

14-1-3.5-15 Operations Restrictions Sec. 15: A person shall not operate a snowmobile:

1. At a rate of speed greater than is reasonable and proper having due regard for conditions that exist.

2. While under the influence of an intoxicating liquor or unlawfully under the influence of a narcotic or other habit forming or dangerous depressant or stimulant drug.

3. During the hours from one-half (1/2) hour after sunset to one-half (1/2) hour before sunrise without displaying a lighted headlight and a lighted taillight.

4. In any nursery, planting area, or public lands posted or reasonably identified as an area of forest or plant reproduction and when growing stock may be damaged.

5. On the frozen surface of

public waters within one hundred (100) feet of a fishing shanty or shelter except at a speed of five (5) miles per hour or less.

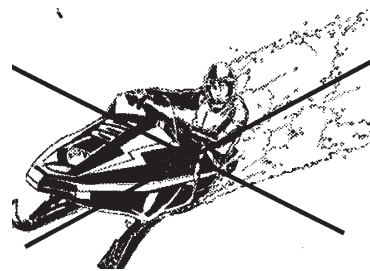
6. Unless equipped with a muffler in good working order and in constant operation to prevent excessive or unusual noise and annoying smoke.

7. Within one hundred (100) feet of a dwelling between 12 midnight and 6 a.m., except on his own property or property under his control or as an invited guest.

8. On any property without the consent of the landowner or tenant thereof.

9. While transporting thereon a bow unless unstrung, or a firearm unless unloaded and security encased or equipped with and made inoperative by a manufactured key locked trigger housing mechanism.

10. On or across a cemetery or



burial ground.

11. Within one hundred (100) feet of a slide, ski or skating area, except for the purpose of servicing the area.

12. On a railroad track or railroad right-of-way, except railroad personnel in performance of their duties.

13. On public property unless authorized to do so.
