She has always loved homes. When she was in elementary school, she pretended to design homes and got really into architecture and art. After graduating from IU Bloomington, she worked in banking/lending and title insurance and learned the other facets of the housing industry. As a realtor, she has been able to combine

her professional background and her hobbies and interests into a career! Her son, Carter, is attending Ivy Tech Community College, studying Hospitality/Culinary, so he keeps her well fed, which she appreciates. In addition to gardening, she enjoys golfing, DIY/home improvement projects and girls' trips to the casino.

How would you describe your style?

I think my style is eclectic. I like bright colors and high energy pieces and mixing and matching art, plants, and things that are meaningful to me. Some rooms in

my home are more traditional or contemporary and other spaces lean towards maximalism or glam.

Tell us a little about each of the areas of your home you chose to highlight. Why did you choose them? What makes them your faves?

My formal living room was my project last winter. It was an unused space in our home. I had been following many of the maximalist Facebook groups for inspiration and decided to try something completely different. I gutted the room and kept only the crown moulding. I created new wood casings for the windows and doorways that had a more decorative flair. I added ornamental moulding to the walls, wallpapered the ceiling and put in a new LVP flooring. I wanted a space that was comfortable and inviting and where I could drink my coffee in the mornings. Once I decided on the wallpaper for the ceiling, everything else just came

together. It became my "anything goes" space, and I absolutely love it.

The formal dining room is off the living room, so I did want there to be some cohesiveness between the two rooms, but not as bold as the living room. I have been collecting art of all kinds for some time, but never really had a way of display it, so I started experimenting with gallery walls. I also bring in (too many) plants for the winter to take advantage of the natural light from the big window.

I also chose to highlight the exterior of my home and some of my gardens. I enjoy experimenting with different types of gardens and my plantings change year to year. I see outside of my home as an extension of the inside and love to put together my favorite flowers and color combinations. Working in the garden is also my mental release and I think its kind of a neat way to visually share

Have YOU paid Your Dues Yet?

Option 1: Total of \$775.00 due on January 1st, 2024. If payment is not received in 60 days or by March 1st, 2024 **penalties will be charged on March 2nd, 2024.**

Option 2: Two payments of \$402.50 each.

1st payment due on January 1st, 2024. **A property lien will be filed and penalties will be charged on March 2nd, 2024. You will lose the option for a two part payment and the full amount must be paid.**

2nd payment due on May 1st, 2024 or by June 29th, 2024. **A property lien will be filed and penalties will be charged on June 30th, 2024.**

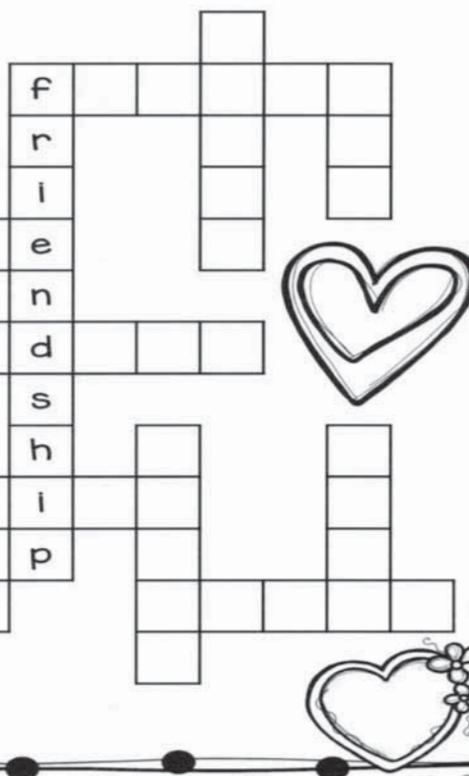

Indiana Snowmobile Laws

14-1-3.5-15 Operations Restrictions Sec. 15: A person shall not operate a snowmobile:

1. At a rate of speed greater than is reasonable and proper having due regard for conditions that exist.

2. While under the influence of an intoxicating liquor or unlawfully under the influence of a narcotic or other habit forming or dangerous depressant or stimulant drug.

3. During the hours from one-half (1/2) hour after sunset to one-half (1/2) hour before sunrise without displaying a lighted headlight and a lighted taillight.

4. In any nursery, planting area, or public lands posted or reasonably identified as an area of forest or plant reproduction and when growing stock may be damaged.

5. On the frozen surface of

public waters within one hundred (100) feet of a fishing shanty or shelter except at a speed of five (5) miles per hour or less.

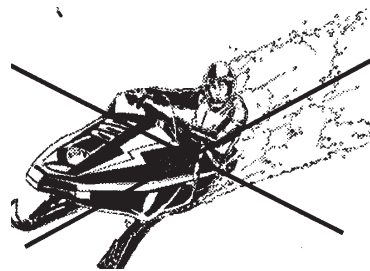
6. Unless equipped with a muffler in good working order and in constant operation to prevent excessive or unusual noise and annoying smoke.

7. Within one hundred (100) feet of a dwelling between 12 midnight and 6 a.m., except on his own property or property under his control or as an invited guest.

8. On any property without the consent of the landowner or tenant thereof.

9. While transporting thereon a bow unless unstrung, or a firearm unless unloaded and security encased or equipped with and made inoperative by a manufactured key locked trigger housing mechanism.

10. On or across a cemetery or



burial ground.

11. Within one hundred (100) feet of a slide, ski or skating area, except for the purpose of servicing the area.

12. On a railroad track or railroad right-of-way, except railroad personnel in performance of their duties.

13. On public property unless authorized to do so.

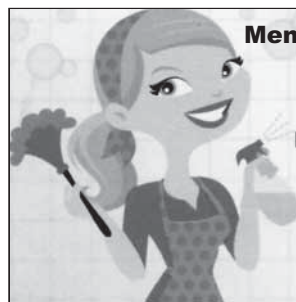
