2024 MANAGER'S SPEECH

Did you know according to Gov. Holcomb the Indiana Model a pathway to create sustainable, generational change elevates Indiana to the next level? There was a 250 million Lilly Endowment grant given expected to provide change to all corners of the State. We are all glad to be Hoosiers!

Arlington Park's Board of Directors have been able to keep dues increases to less than the cost of living over the past many years, but also have been able to create set aside monies to maintain our sustainable, and generational changes in Arlington Park. Arlington is on the right path.

Over the past four years we have welcomed 336 new families in Arlington Park. They selected Arlington due to the growth of the city of Fort Wayne and settled in Arlington Park. Gov. Holcomb said the rural and mixed-rural counties captured \$148.7 billion in capital commitments, resulting in more than 15,000 new jobs. Arlington has realized a growth of families by 32%.

Many of you are new to Arlington Park and are just beginning to enjoy our many amenities. The clubhouse was built in 1974, sits on 3.84 acres and is 11,800 sq. ft. The Pro Shop was built in 1982. The golf course, designed by DuWayne Daymeyer and Richard Chilcote, opened for play in May of 1979. Arlington has seven tennis courts, seven playgrounds, 15 acres of ponds and lakes and 15 miles of sidewalks. Arlington has been featured in four parades of homes and most recently in the Home and Design Guide as #1 in "25 Neighborhoods we Love."

In 2024 we welcome our new Executive Director Millie McDonald beginning April of this year. Millie described herself as having a strong ability to think outside of the box, a great communicator, compassionate/passionate and au-

thentic. I hope you will embrace all that she has to offer Arlington Park.

Gary Johnson is returning as the Arlington Golf Pro. We look forward to the return of Vince Williams, Arlington Tennis Pro teaching Arlington residents for the past 14 years. Vince has taught over 845 kids how to play tennis and two of his students won Indiana State Doubles. Back for his third year is enthusiast Matt Bradenberger as IPTPA Arlington Pickleball instructor.

We are also fortunate to have Brooke Blackman return as the representative of Swim/Dive teams and Coach Gibson for Arlington Park Swim Team. This quality time, from each of us, will offer Arlington children wonderful opportunities with expertise and fun!

This is Jessica Clarke's second year as secretary for the front office and has enjoyed meeting all of you! In addition you will see, with smiling faces, Pat Davis-Sauers as bookkeeper, Rick Rupel, Jerry Baker and Tim Keck create the maintenance crew. Zach Zimmerman as head of the security team and Nick Tesco keeping our greenway lights lit!

As in past years I encourage each of you to drop us an email, let us know what we do great and what we do not so great, both are received with equal interest!

Last, but never least, remember to thank the current Board of Directors and those leaving the Board for their time and energy dedicated to the Arlington community. Volunteers are "very special people" that deserve to know how much you appreciate them and all they do for you. We would not be Arlington Park without them!

Members Do Mind!

- Do you allow your dog to bark relentlessly?
- Do you let your dog off leash to cruise the park?
- Do you let your cat or dog outside to run the neighborhood?
- Do you fail to scoop up after your dog or cat in public areas?



Everyone loves a pet until it becomes a neighborhood nuisance. Be a responsible pet owner and a considerate neighbor. City leash laws and sanitation laws are actively enforced for both cats and dogs. A message from the City of Fort Wayne and the Animal Care and Control Department.

How to be a Good Neighbor

Listed below are a few helpful suggestions from our Architectural Committee.

New Paint: Homeowners are free to repaint their homes using a color identical to the existing paint.

Roof Treatment: When a home requires a new roof, homeowners are free to re-roof their homes using the identical color and type of shingle found on the existing home.

Antennas and Satellite Dishes: Satellite dishes are required to be less than 36 inches in diameter to be placed at the rear of the house, not visible from the street and to be screened from view from the neighbors.

Play Equipment and Toys: Arlington Park is a family community so children are an important part of our community. In order to maintain harmony children's toys should be stored indoors or in an orderly fashion that they are screened part of the backyard not visible from public view. Bicycles and other riding toys should be kept in the garage when not in use. No play structure or equipment is allowed in the common areas.

Swimming pools: Portable swimming pools are prohibited in the covenants. A child pool that can be emptied and stored

every evening, out of sight, is permitted.

Lighting: Tasteful accent lights are encouraged and security lights that do not create a nuisance for other homeowners are permitted.

Garage Doors: Garage doors should be opened only long enough to permit car access to garage or while someone is working outdoors.

Before you begin: A note from Architectural Control

Arlington Park Community Association Architectural Control Guidelines and Policy.

In order to maintain harmonious structural design and lot grades, the Board of Directors of the Arlington Park Community Association has adopted the following architectural Control Guidelines and Policy to be followed by the Architectural Control Committee in its review and approval for improvements to property within Arlington Park as provided by the restrictive covenants of the various sections of Arlington Park.

Accessory Building: Where permitted by restrictive covenant, an accessory building should not exceed 144 square feet in the area and ten feet in height above grade. The building's exterior color, siding and roofing materials shall be the same as the dwelling on the lot. The accessory building may not be within an easement per the Arlington Park Covenants and Bylaws and the City Zoning Ordinance. The City Zoning requires that an Improvement Location Permit be

applied for an issued. Placement of the detached accessory shed located behind a residential structure shall use the following set backs: for interior lots at least 3' (feet) from side and rear property lines and for corner lots no less than the platted side yard setback.

Fences: No wire, metal or chain link fences will be permitted, however, a small woven wire fence may be used in conjunction with a split rail or similar fence in a side or rear yard to contain a pet. The Board recognizes that many residents may wish to erect a fence within an easement. While the Architectural Control committee may approve a fence for design purposes, the property owner must assume all responsibility for providing unobstructed access to the easement for utility purposes. Moreover, the expense of removing or replacing a fence within an easement is the sole responsibility of the property owner.

Playground Equipment: Plans for playground equipment, basketball courts, etc. shall be submitted

to the Architectural Control Committee for review so as to assure compliance with yard requirements. Equipment that becomes unsightly because of lack of maintenance, repair or use should be removed.

Dog Runs and Kennels: dog-houses, kennels or dog runs shall not be allowed or approved. No area within a front, side or rear yard shall be enclosed or fenced so as to provide a run for a dog. However, this requirement does not preclude a resident from fencing an entire yard and permitting a pet to run therein.

Antennas and Satellite Receivers: No free-standing antennas or television satellite receivers shall be permitted on any lot. When allowed by restrictive covenant, an antenna or receiver not exceeding 30 square feet in area or 6 feet above the highest point of the roof area may be attached to the dwelling or receiver not exceeding 30 square feet in area of 6 feet above the highest point of the roof area may be attached to the dwelling.

BY-LAWS OF ARLINGTON PARK ASSOCIATION, INC. ARTICLE 1 DEFINITIONS

Section 7. "Lessee" shall mean and refer to a person leasing from an Owner, whether one or more persons or entitles, of any Living Unit situated within the Properties. "Lessee" shall mean and refer to a person leasing from an Owner, whether one or more persons or entitles, of any Living Unit within the Properties. The term "renter" may be substituted for "Lessee." A Lessee is further defined as person or single-family leasing or renting a Living Unit from an owner, as defined in Section 6 above, for a period of time no less than 6 months in length and having an agreement, in writing, signed and dated by the Lessee and Owner, as defined in Section 6 above, filed with and approved by the Executive Director under authority of the Arlington Park Board of Directors prior to occupancy. Member privileges shall NOT be extended to occupants until and unless the Executive Director and/or Board of Di-

rectors approve the conditions of the lease. Under no circumstances shall a Living Unit be utilized for commercial purposes or rentals/leases of duration less than six (6) months or that otherwise fail to meet the full rental/lease requirements detailed above. Additionally, under no circumstances shall a Living Unit be utilized for short-term lodging. Prohibition of Living Unit use as short-term lodging includes but is not limited to prohibition of Living-Unit-based Bed and Breakfasts, VRBO rentals, AirBnB rentals, and any other form of short-term lodging that may be, as of writing, categorized under the North American Industry Classification System (NAICS) codes 72119, 721191, and 721199. Any other form of Living Unit use that serves similar function as the aforementioned businesses and/or business structures encompassed by the above-referenced NAICS codes is prohibited.

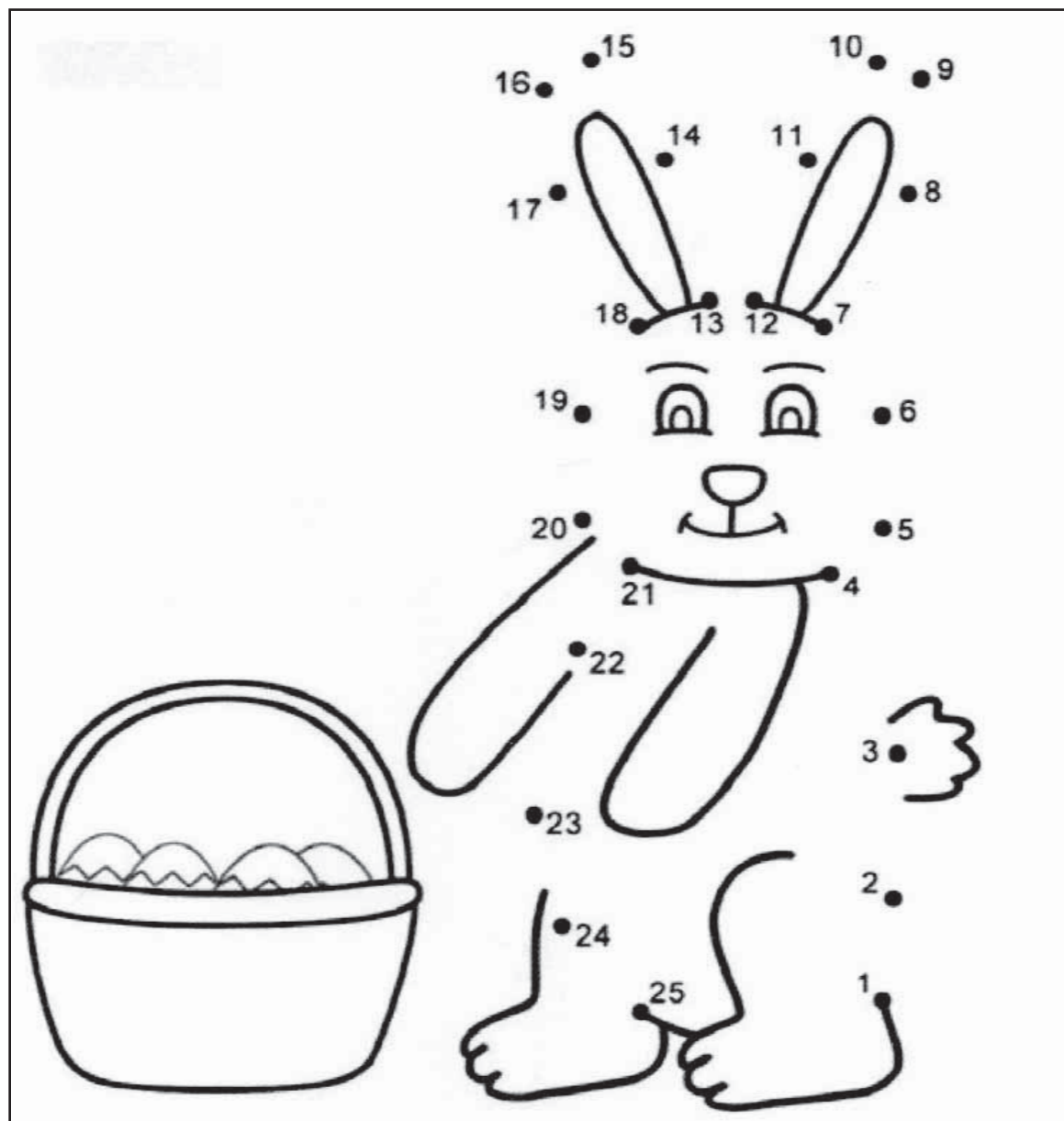

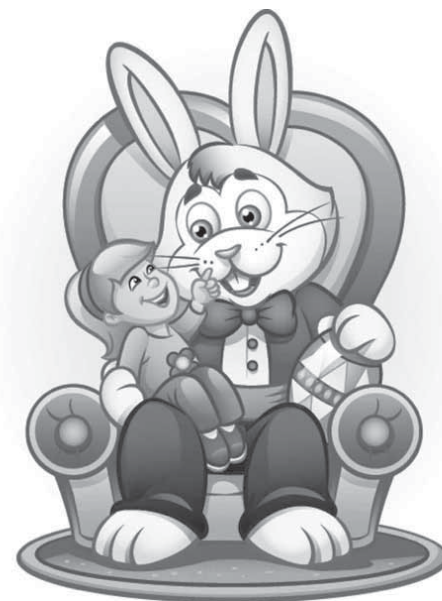

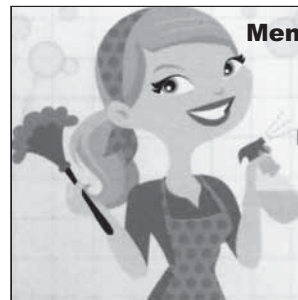
